Jarosław Suchoples - Ph.D., Dr. Suchoples received his MA from the University of Gdańsk, Poland, in 1993. He holds a Ph.D. in History from the University of Helsinki (2000). In 2000-2001, he was an analyst at the Polish Institute of International Affairs in Warsaw, Poland. From 2001 to 2002, he was a visiting researcher at the Department of Political Science of the University of California, Berkeley. Between 2003 and 2013, he lectured at the Willy Brandt Centre for German and European Studies in Wrocław, Poland, at the Nordeuropa-Institut of Humboldt University in Berlin and Free University Berlin, Germany, and at the universities in Olsztyn and Szczecin in Poland. From 2013 to 2015, he was an associate professor at the Institute of Malaysian and International Affairs (IKMAS) of the National University of Malaysia (UKM). In 2017, he returned to Finland, this time as Ambassador of Poland. Currently, Dr. Suchoples is a Senior Research Fellow at the Department of Music, Art, and Culture Studies of the University of Jyväskylä, Finland. He is involved in a variety of projects on the History and Memory of World War I, World War II, and the Cold War.

Arto Nokkala – Doctor of Social Sciences, Lt. Col. (GSO) Ret., is Adjunct Professor (Title of Docent) of strategic studies and security policy at the Finnish National Defence University (FNDU). He is also an independent researcher. Dr. Nokkala has published monographs and articles on security and strategic studies, foreign, security and defence policy, military politics, armed forces in wide security, conscription, the professionalisation of the military, northern regional security, and non-offensive defence. He is a former Director of the Office of Strategic Studies at the Finnish War College. After an officer's career in the Finnish Defence Forces, he worked at the University of Tampere as a Senior Assistant and Senior Research Fellow and was a visiting researcher at the Tampere Peace Research Institute (TAPRI). He has also lectured in many other universities. He was the Chair of the Finnish Geopolitical Association between 2020–2022.

Stefan Lundqvist – Ph.D., Dr. Lundqvist is a Director of Studies (advanced level) in the Department of Military Studies of the Swedish Defence University (SEDU), where he has served as a military lecturer

since 2010. He is an active duty officer (Commandor) who holds a Ph.D. in political science from Åbo Akademi University, Finland. Until this marked turn towards academia, Dr. Lundqvist served in sea-and-shore-based staff positions at tactical and operational levels of command. His areas of expertise include International Relations, strategy, military theory, maritime security, operational planning, and operations assessment. He is a sought-after expert on maritime security and strategy. Stefan Lundqvist is a member of SEDU's Research and Education Board, chairing its Syllabus Committee while serving on the Committee on War Studies. His research has appeared in books and journals including *Defence Studies* and the *RUSI Journal*. His current research focus is on security in the Arctic and Baltic Sea regions.

Ralph Tuchtenhagen – Ph.D., Professor of Scandinavian Cultural Studies (with an emphasis on North European History) at Humboldt University, Berlin/Germany. Dr. Tuchtenhagen studied History, Scandinavian, and German Studies at Freiburg University/Germany, and at Sorbonne University, Paris/France. In 1987, Dr. Tuchtenhagen attained a Ph.D. on the Russian Tsarist government's policy on religious minorities in the Russian Empire, 1905–1917. Between 1993–2003, he served as Assistant Professor of Eastern European History at Heidelberg University. In 2001, his second book ("Habilitation") on the integration processes of the central administration and provinces in Sweden and Russia c. 1560–1800 was published. From 2002–2003, he was a visiting professor at Saarland University. For seven years between 2003–2009, he was Professor of Eastern and Northern European History at Hamburg University. In 2008, he was a visiting professor at Södertörn University, Stockholm/Sweden, and in 2013 he was Guest Researcher at the European University in Florence, Italy. The following are Dr. Tuchtenhagen's main interests in research and teaching: the history of the Baltic Sea region, the history of the North Atlantic, and the human history of the Arctic. Recent publications: (ed.) Die Schweden im deutschen Südwesten. Vorgeschichte, Dreißigjähriger Krieg, Erinnerung [Swedes in the German Southwest: Prehistory, the Thirty Years War, Commemoration (2020); and Das Baltikum: Geschichte einer europäischen Region [The Baltic States: History of a European Region], 3 volumes (2018–2021).

Tuomo Melasuo – Professor Emeritus of Peace and Conflict Research in TAPRI, Tampere Peace Research Institute, Tampere University, and Docent in Political History, University of Turku, Finland. He studied contemporary history and political science in Turku in Finland and in

Aix-en-Provence in France. Professor Melasuo specialises in the North African and Mediterranean world, especially on Algerian history since the beginning of colonialism. He has also worked on other Maghrebi countries, on political culture in Muslim societies as well as on the history of colonialism. During the last three decades, since creating the TAPRI Mediterranean Studies Project, Tuomo Melasuo has been active in Euro-Mediterranean relations. He is or has been a member of many scientific, cultural, and civil society organs such as the Advisory Council of Anna Lindh Foundation, Academic Advisory Council in the Center for Mediterranean Dialogues of the New York University, in steering committees of Femise, IASKS, and of Sihmed. On a more global level, professor Melasuo has served as the Vice-President of the MOST (the Management of Social Transformation program, Unesco) representing Western Europe and North America as well as serving as a representative of Finland in Unesco's Euro-Arab Task Force for Dialogue. Tuomo Melasuo has published several books and many articles both in international and Finnish publications. Today, besides guiding his doctoral students, professor Melasuo continues his scientific activities in peace and conflict research on Euro-Mediterranean relations by concentrating on socioeconomic evolutions in international political and cultural relations both in a regional and global context. Tuomo Melasuo has been designated Chevalier dans l'Ordre des Palmes Académiques.

Marko Ala-Fossi – University Lecturer in Journalism and Adjunct Professor (Title of Docent) at Tampere University, Finland. Before his academic career, Dr. Ala-Fossi worked as radio news journalist, news producer, and market analyst at Yleisradio, the Finnish public service broadcasting company. He was a visiting research fellow at the University of Leeds, UK, in 2015. Dr. Ala-Fossi has also published widely on media policy in peer-reviewed academic journals and coordinated several policy reports, most recently in two national media policy research projects (2017–2018, and 2019) commissioned by the Finnish Ministry of Transport and Communications. He is the author of 80 research publications.

Mikko Grönlund – Research Manager of the Brahea Centre at the University of Turku. His work has concentrated on issues such as media business models, the economic development of the communications industries, concentration and ownership in media markets, the impact of digitalisation on different media and creative industries, and the financial implications of copyright industries. He has published research articles in edited volumes and journals including the *European Journal*

of Communication, Journalism, Journal of Media Business Studies, Digital Journalism, Journal of Radio and Audio Media, and Nordicom Review.

Heikki Hellman – Docent at the Faculty of Information Technology and Communication Sciences, Tampere University. He forged a long career as a journalist and cultural editor in *Helsingin Sanomat*, Finland's leading daily, while also undertaking his doctoral studies at the University of Tampere, Finland, and the University of Westminster, London. Later, he served as Professor of Practice in Journalism at the University of Tampere and, then, as Dean and Senior Research Fellow at its School of Communication, Media and Theatre. For five years, he also served as a member on the YLE (Finnish Broadcasting Company) Board of Executives. His research interests include media policy, media competition, journalism research and audience research. His major monograph, Koko illan ilo? (2012), deals with the commercialisation of television and the liberalisation of media policy in Finland. He has published dozens of research articles in edited volumes and journals including the European Journal of Communication, the International Communication Gazette, the Journal of Media Economics, Journalism Practice, Media, Culture & Society, Radio Journal, and Television & New Media.

Katja Lehtisaari – Senior Lecturer in Journalism at Tampere University, Finland and Adjunct Professor (Title of Docent) at University of Helsinki. Dr. Lehtisaari is the head of Tampere Research Center for Russian and Chinese Media (TaRC) and her research topics vary from changing media structures and journalism to media business and media policy, often in an international, comparative setting. She was a visiting research fellow at the Reuters Institute, University of Oxford, UK, in 2015, and at the Woodrow Wilson International Center for Scholars, Washington D.C., in the United States in 2018. Her publications include co-edited books and a wide range of chapters in edited books and articles in peer-reviewed journals.

Kari Karppinen – Doctor of Social Sciences, University Lecturer in Media and Communication Studies at the University of Helsinki, Finland. Dr. Karppinen's research interests include media and communication policy, conceptions of media freedom and pluralism, theories of democracy and the public sphere, and questions about digital rights and internet governance. The author of over 50 scientific publications, including the book *Rethinking Media Pluralism* (Fordham University Press, 2013).

Hannu Nieminen – Professor Emeritus of Media and Communications Policy at the University of Helsinki and professor (part-time) at the Vytautas Magnus University, Kaunas. Between 2022–2025, he is a visiting professor at the London School of Economics and Political Science (LSE). He was the Dean of the Faculty of Social Sciences from 2016 to 2019 and Director of the Helsinki Institute for Social Sciences and Humanities in 2020. He has published extensively on media and democracy, communication rights, the European public sphere, and media and inequality. He is a member of the Euromedia Research Group, and a member of several editorial boards, including Javnost/The Public, Global Communication, World of Media, and Communication and the Public. He serves an expert on Public Service Broadcasting for the Administrative Council of the Finnish Broadcasting Company YLE.

Jan Otto Andersson – Docent in International Economics at Åbo Akademi University, Finland. Retired acting professor in Economics. Dr. Andersson has a storied history as a researcher abroad, including stints in Stockholm between 1966–1969, Moscow in 1974, Budapest in 1978, Aalborg in 1980, Grenoble and Paris in 1982, and London between 1988–1989. His published works include the books: Studies in the Theory of Unequal Exchange between Nations (1976), Den förbryllande nationalstaten (1982), Vänsterframtid – Nationalekonomiska studier av fordismens kris och morgondagens alternativ (1988), and Elements of Ecological Economics (with Ralf Eriksson), (2010). Dr. Andersson is also the author of articles on the Nordic economic and social models, European integration, basic income, degrowth, and ecologically unequal exchange.

Natalia Kohtamäki – Ph.D. (Dr. habil.), and a Professor at the Faculty of Law and Administration of Cardinal Stefan Wyszynski University in Warsaw. Dr. Kohtamäki completed her doctoral studies at the interdisciplinary college *Global Financial Markets* at the Faculty of Law, University of Jena. She is also a graduate of law and international relations at the University of Warsaw and postgraduate studies in comparative law at the Faculty of Law of the University of Bonn (LL.M.). She is the holder of scholarships granted by prestigious German institutions supporting science, including the Max Planck Institute for Public Comparative Law and International Law in Heidelberg, and the German Bundestag (IPS), and the foundations Stifterverband für die Deutsche Wissenschaft and Stiftung *Geld und Währung*. She is also the head of two research projects funded by the National Science Center (NCN), and a member of a research team in three German-Polish projects. Additionally, she is the author

of numerous publications on European administrative law, including monographs in English (*Theorising the Legitimacy of EU Regulatory Agencies*, Berlin 2019), and German (*Die Reform der Bankenaufsicht in der Europäischen Union*, Tübingen 2012).

Adam A. Ambroziak – Ph.D. (Dr. habil.), and a Professor at the SGH Warsaw School of Economics, specialising in the EU internal market policy, state aid policy, cohesion policy, common commercial policy, industrial policy, and in using EU funds. Dr. Ambroziak is an expert in the decision-making process in the European Union and in EU lobbying. He is the Head of the Postgraduate Programme in State Aid, the Head of the Postgraduate Programme in Administration and Management, and the author of over 150 scientific books, chapters, and science journals published by prominent international publishers, including Springer, Routledge, Taylor&Francis Group, as well as being responsible for analyses drafted for the Polish administration and international organisations on the EU's economic policy, state aid policy, and on the EU's internal market. He is actively involved in Poland's EU association, accession, and membership. While he is a lecturer and trainer in European economic integration and in European lobbying, and is actively involved in Poland's EU association, accession negotiations and in the adjustment of the Polish legal system and economy to the provisions of the Europe Agreement, he is, in addition, a lecturer at the Warsaw School of Economics, Centre for Europe at the University of Warsaw, at the University of Gdańsk, at the National School of Public Administration in Poland, and at the Polish Institute of International Affairs.
